

# STUDENT & PARENT/GUARDIAN AGREEMENT 2020

Agreement between the Student and Parent/Guardian and **Forest Hill College Academy (FHC Academy)**.

## 1. INTRODUCTION AND TERM

- 1.1 You have been selected as a member of the FHC Academy by satisfying the sporting, academic and behavioural criteria. Program participants are reviewed every 12 months to determine whether they remain in the FHC Academy for the following year.
- 1.2 This Agreement contains the terms on which you have been selected and which must be adhered to as a member of the FHC Academy.
- 1.3 The terms of this Agreement are valid for your enrolment in the FHC Academy Program and are agreed to and signed each year.
- 1.4 "The Program" refers to the program for which you have been selected.

## 2. STUDENT BENEFITS - You will receive:

- 2.1 Access to a holistic program that balances academic achievement and sporting/performing excellence.
- 2.2 Access to strength and conditioning programs, coaching personnel and associated fitness facilities.
- 2.3 Access to personal development programs including camps, guest speakers and excursions.
- 2.4 Interim reporting Term 1 and Term 3 with full reporting twice per year at the end of each Semester. Regular contact with athletic and/or performance staff to remain up to date with student progress.

## 3. OBLIGATIONS - You must:

- 3.1 Attend all scheduled FHC Academy sessions unless otherwise agreed with Academy staff.
- 3.2 Comply with the direction of Forest Hill College staff, program coaches and the Director of Sport and Performance.
- 3.3 Consistently demonstrate elite sporting behaviors.
- 3.4 Maintain a satisfactory GPA and a positive attitude to your studies.
- 3.5 Wear full academy uniform when engaging in academy activities and wear full Forest Hill College uniform (including Physical Education) when not participating in academy activities.
- 3.6 The FHC Academy programs are Optional Items as defined by the Education and Training Reform Act (2006). Students access the programs on a user pays basis. The non-payment of program fees will result in the withdrawal of the student from the program, unless suitable arrangements are made with the College.
- 3.7 Pay FHC Academy fees on acceptance of a place in the program in accordance with the specified payment options.
- 3.8 Comply with WADA & ASADA regulations in regard to prescription medications and banned substances.

## 4. MEDICAL

- 4.1 If you are ill, injured or involved in an accident, parents authorise the administering of medical treatment and agree to pay for the cost of any such treatment. In all cases, parents/guardians will be contacted. Due to an increased risk of injury as a result of increased training, FHC recommends Parents/Guardians consider private health insurance.

## 5. BREACH BY AN ACADEMY STUDENT PROGRAM PARTICIPANT

- 5.1 If you do not comply with this Agreement, Forest Hill College may preclude you from participating in the FHC Academy. All students will adhere to the expectations, procedures and policies of Forest Hill College and the FHC Academy.
- 5.2 Enrolment of students at FHC Academy is conditional upon them meeting the behavioural and attitudinal requirements set by the teaching staff. Students who elect to withdraw from the FHC Academy, fail to pay mandatory FHC Academy fees or are excluded from the program because of behaviour or attitude will be required to forgo their enrollment in the program.
- 5.3 Students who fail to meet obligations as outlined in items 3.1 - 3.8 will undertake an academic review and steps will be taken to support enhanced outcomes.

## 6. ADJUSTED ACADEMY PROGRAM

- 6.1 Adjustments to the program will be made in consultation with the Director of Sport and Performance should injury, medical condition or study impede program participation.

## 7. DISCLOSURE OF PERSONAL INFORMATION

- 7.1 Forest Hill College and the academies may at times require sharing of information of a personal nature. I agree that such information may be made available where necessary.
